Yearly Review, a journal of the Department of English, University of Delhi provided a forum for academic discussion amidst changes in literary scholarship. It broadened the scope of enquiry to include pedagogical debates on theory and form. The articles in the Yearly Review were selected to reflect international developments in re-thinking English studies; the section on book reviews purposefully laid stress on publications from India.
